Preface

This conference is direct continuation of the 1st conference in Marseilles, CIRM, France, January 21–25, 2008, and the 2nd conference in Strobl am Wolfgangsee, Austria, July 5–9, 2010. The first conference was organized by Vladimír Baláž and Pierre Liardet, with more than 70 participants representing 16 countries and 42 talks was given. The proceeding of this Conference was published by the journal Uniform Distribution Theory Vol. 3, no. 2, 2008. The second conference was organized by Friedrich Pillichshammer, with 55 participants representing 16 countries and 40 contributed talks and proceedings was published by the same journal Vol. 6, no. 1, 2010.

The third meeting had 48 participants representing the countries Australia, Austria, Bulgaria, Czech Republic, France, Hungary, Italy, Japan, Lithuania, Mexico, Poland, Russia, Slovakia, United Kingdom and United States.

The program of the conference consisted of the 11 plenary talks and 29 regular talks covering topics from Number Theory that can be summarized under the key words: *Quasi-Monte Carlo method, discrepancy, diaphony, L_p -discrepancy, star discrepancy bound, van der Corput sequence, (t, s) -sequence, Zaremba-Halton net, polynomial lattice point set, binary sequence, linear recurring sequence,*

Zaremba-Halton net, lattice point problem, hybrid point sets, elliptic power generator, Hilbert space with reproducing kernel, Hausdorff dimension, permutation polynomials, Farey fractions.
